**General instructions:**

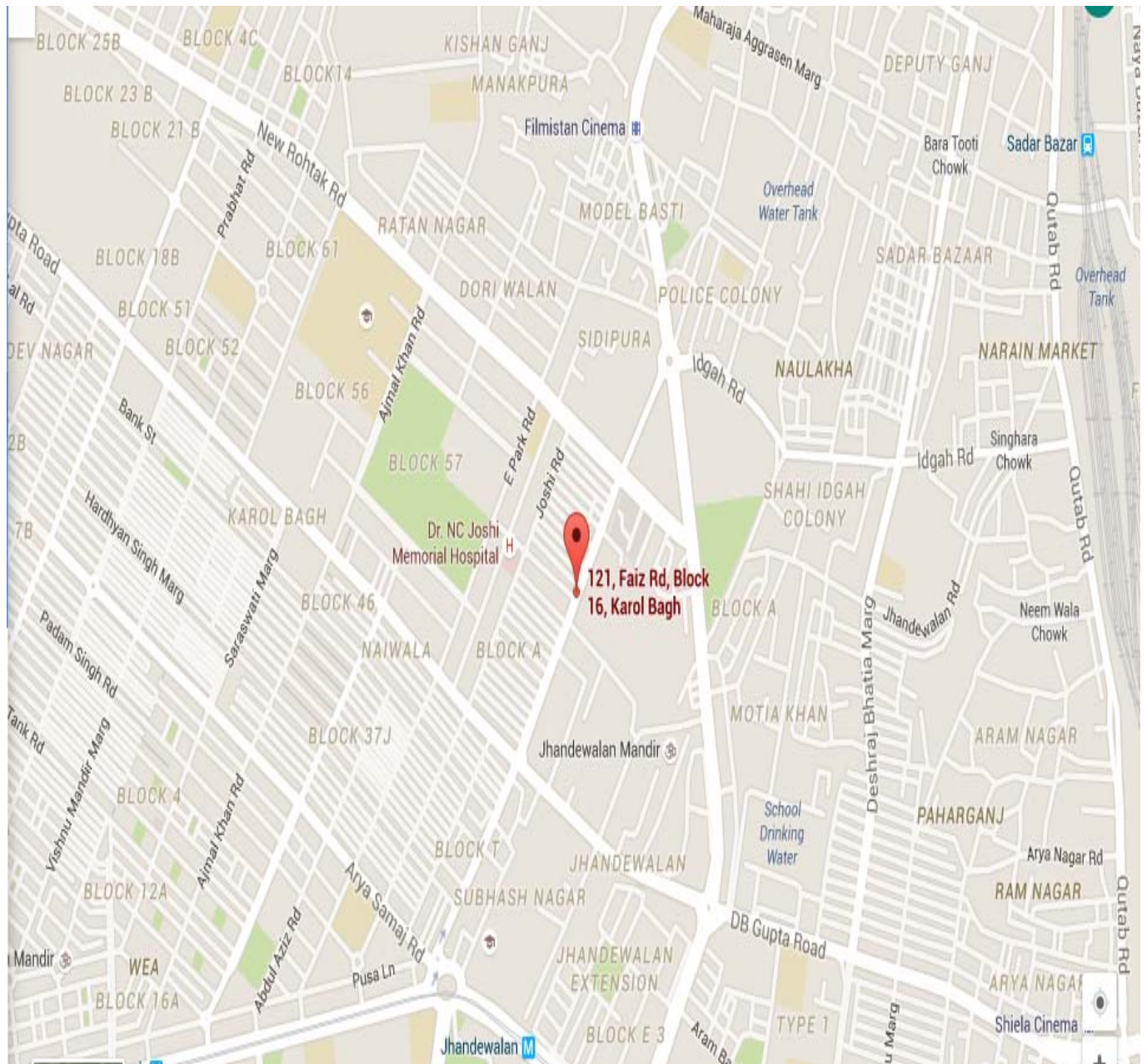

## **4. DIVIDEND:**

*As the company has incurred loss, So the company has no adequate funds to recommend any dividend. But the directors are hopeful better result in ensuing future.*

## **5. SHARE CAPITAL:**

*In order to meet the additional working capital requirement of funds and to augment the capital base of the company for expansion and growth of the company. The funds raised by the company shall be utilized for its present business operation or in such other manner as may be decided by the Board of Directors in the interest of the company.*

*The Company has allotted 1,00,000 equity shares of ₹ 10/- each at a premium of ₹ 215/- each by the preferential issue of equity shares to non promoter group by passing the special resolution through postal ballot vide notice dispatched dated 25<sup>th</sup> August, 2014.*

*Therefore, The paid up Equity Share Capital is ₹ 1,35,00,000/- as on 31<sup>st</sup> March, 2016.*

## **6. DEPOSITS:**

*During the year, the Company has not invited/accepted any deposits under Companies Act, 2013.*

## **7. PARTICULARS OF LOANS, GUARANTEES OR INVESTMENTS:**

## **10. DIRECTORS AND KEY MANAGERIAL PERSONNEL:**

### **a) RE-APPOINTMENT OF DIRECTOR:**

*Ms. Mehak Arora, Director of the Company, is liable to retire by rotation at the ensuing Annual General Meeting and being eligible, offers herself for re-appointment. The Board of Directors recommends her re-appointment.*

### **b) CESSATION OF DIRECTOR**

*During the year, Mrs. Mamta expressed their inability to continue as a director, due to their other commitments and submitted their resignation and ceased from the board w.e.f 27<sup>th</sup> April, 2016. The Board of Directors has accepted the same and placed on record their appreciation for the services rendered by them during the tenure period of their directorship.*

### **c) INDEPENDENT DIRECTORS:**

*The Independent Directors hold office for a fixed term of five years and are not liable to retire by rotation.*

*The Independent Directors have submitted their disclosure to the board that they fulfill all the requirements as to qualify for their appointment as an Independent Director under the provisions of the Companies Act, 2013 as well as SEBI (LODR) Regulations, 2015.*

### **d) BOARD EVALUATION:**

*Pursuant to the provisions of the Companies Act, 2013 and SEBI (LODR) Regulations'2015, the Board has carried out an annual performance evaluation of its own performance, the directors individually as well as the evaluation of the working of its Audit Committee, Nomination & Remuneration Committee, Stakeholders' Relationship Committee and Risk Management Committee.*

### **Note1: SIGNIFICANT ACCOUNTING POLICIES**

a) **Basis for Preparation of Accounts :**

Although these estimates are based upon management’s best knowledge of current events and actions, actual results could differ from these estimates. Any revisions to the accounting estimates are recognized prospectively in the current and future years*

c) **Loan Income:**

*In respect of loan agreements, the income is accrued by applying the implicit rate in the transaction on declining balance on the amount financed for the period of the agreement.*

d) **Accounting of Inventories:**

*Stock in trade should be valued at cost or market price whichever is lower, so that the company has valued it’s currently purchased all stock in trade at less value that is cost.*

e) **Employee Benefits**

*Company do not follow the provision of the accounting Standard-15 “Employee benefits” as the company do not have employee more than 10 personnel’s. So it is the policy of the company that any kind of provision mentioned in the AS -15 will not be entertained. And the company does not make provision for gratuity also.
